
Dear Members and Friends,

Other News

Scholarship Award

We would like to introduce Anna Souchuk, our scholarship recipient 2008. She studied Languages and Literature at Yale University and has her first teaching job as Assistant Professor at DePaul University in Chicago.

Her remarks to the A-AA will focus on a subject of her dissertation: The concept of *Gemütlichkeit*. What happens when a city like Vienna represents itself by a quality that inevitably looks to the past, which is the case with this concept. Several important writers have taken issue with this very Austrian self-definition. Modern Viennese authors such as Josef Haslinger, Robert Menasse, and Elfriede Jelinek are critical of Viennese definitions that include Gemütlichkeit. Instead of accepting the concept, they unmask it as potentially artificial or inauthentic, seeing the Viennese instead as performers on a city-stage of their own construction. As a result, this concept of Gemütlichkeit is at the center of a cultural controversy.

Each author examines problems of Viennese identity and Gemütlichkeit differently. For Haslinger, generational conflicts stand in the center of the critique, while Menasse examines Gemütlichkeit as it relates to tourism. Jelinek views the term in relation to the internet, a point made even more striking by her own use of this electronic medium to publish her writings. --- --- ---

We will ask Ms. Souchuk to give her presentation at a date agreeable to both parties.

Austrian Nationalratswahlen

Information regarding the upcoming National ratswahlen 2008 (Elections to the Austrian Legislature) on September 28, 2008

- 1. Only Austrian citizen can vote, and you need to have an Austrian passport.
- 2. As an Austrian living abroad, you need to be registered as a voter at your last Austrian residence (Eintragung in die Waehlerevidence). Previous registrations are valid for ten years.
- 3. You need to have an absentee ballot (Wahlkarte).
